- o The Treasurer reviewed key facts and figures from last year's budget and proposed the 2024-2025 budget.

### V. New Updates on Outstanding HOA Business:

- a. Boat Ramp/ Replacement Updates:
  - -Current Boat Ramp Quote: 32K. we have \$7500 in HOA reserves, Unamious vote to reduce HOA reserves down to 2 years
  - -No legal ramifications as this is not on OFE Property
  - -The HOA Boat Ramp committee (Beebe & Funderburk) have provided a update on cost.
  - -Boat ramp special assessment NOT TO EXCEED \$660 per lot (unanimous Vote to approve)
- b. LED Street Lights Brian Beebe updated HOA on Halifax.
  - a. Halifax is no longer giving us an option; we move to the new LED lights, or they will no longer support the current lights.
  - b. Next step is to find out if the Premium lights will be an additional fee (nontraditional green lights).
  - c. Once we hear from Halifax, have pictures, Brian Beebe will send out for vote. As discussed in annual meeting, tough for us to get a vote,

therefore a Unanimous vote YES to spend up to \$2500 of HOA budget on upgraded LED streetlights (currently have 10 lights)

- c. Speed Limit on N.& S. Robinson as well as E. & W. Pointe legally changed to 25mph. HOA has placed 5 new signs within the boundaries of these changes. We have asked that neighbors renting re-iterate this in their rental agreements and PLEASE if you see something, write down the license plates and report.
- d. Cemetery- Thank you Jeanne Hammer for all the research, no new news to share. NC will not mark graves.

Spectrum Internet- Spectrum high speed internet is being installed throughout Warren County under a Federal grant. Their contract requires them to be complete NLT May of 2025. Please head to the Spectrum website link and sign up with your interest so they'll put us early on the installation schedule.
