- 1. The name of the Corporation is: Olde Ferry Estates Home Owners Association, Inc.
- 2. The street address and county of the initial registered office and principal office for the Corporation is: 115 North Mosby Avenue, Littleton, North Carolina 27850 (Halifax County, North Carolina).
- 3. The mailing address of the initial registered office of the Corporation is: P. O. Drawer 640, Littleton, North Carolina 27850 (Halifax County, North Carolina).
- 4. The name of the initial registered agent of the Corporation is: William T. Skinner, IV.

(b) To establish and collect annual and special assessments from members pursuant to the Bylaws of the Corporation for the purpose of carrying out the objectives and purposes for which this Corporation is established, Assessment shall be equal against all lots or parcels.

(c) To seek to create enforceable assessment provisions for establishing and collecting annual and special assessments from its members for carrying out the other purposes and objectives for which this Corporation is organized;

(d) To purchase or otherwise acquire, own, improve, convey or otherwise dispose of real estate within the Olde Ferry Estates subdivision;

(e) To purchase, own and operate property and equipment for performing the other services duties, purposes and objectives of this Corporation;

(f) To contract with others for performing the services, duties, purposes and objectives of this Corporation;

(g) To purchase, construct, operate and maintain recreational equipment and facilities on park areas and other common properties within the Olde Ferry Estates subdivision;

The membership of the Corporation shall be limited to those persons and/or any other legal entities who own any lot that lots, or an interest in such lot or lots which are located within the Olde Ferry Estates subdivision and which subdivision is located in Sixpound Township, Warren County, North Carolina. Each lot which is located within the Olde Ferry Estates subdivision shall have one (1) membership and its owner or expers shall have one (1) vote.
